This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. Our water source is purchased from the City of Greensburg, which is treated surface water from the Flat Rock River, northwest of the City of Greensburg. Greensburg also uses a ground water source from six wells in the City of Greensburg.

We're very pleased to report that our drinking water is safe and meets Federal and State requirements. Decatur County Rural Water Corporation routinely monitors for constituents in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1st to December 31st, 2022 All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

All sources of drinking water are subject to potential contamination by constituents that are natural occurring or manmade. Those constituents can be micro, organic, or inorganic chemicals, or radioactive materials.

The sources of drinking water (both tap and bottled water) include river, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or throughout the ground, it dissolves naturally occurring minerals and, in some cases, radioactive can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic system, agricultural livestock operation and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agricultural, storm water runoff, and residential areas.
- Organic chemicals, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production and can also, come from gas stations, urban storm water runoff, and residential uses.
- Radioactive materials, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water, which must provide the same protection for public health. Some people may be more vulnerable to contaminants in drinking water than the general population. In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions.

- Parts per million (ppm) or Milligrams per liter (mg/l) one part per million corresponds to one minute in two years or a single penny in \$10,000.
- Parts per billion (ppb) or Micrograms per liter one part per billion corresponds to one minute in 2,000 years or a single penny in &10,000,000.
- **Nephelometric Turbidity unit (NPU)** nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.
- <u>Action Level</u> (AL) the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- **<u>Treatment Technique (TT)</u>** A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.
- <u>Maximum Contaminant Level</u> (MCL) (mandatory language) The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCL's are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG) (mandatory language) The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- Maximum Residual Disinfectant Level (MRDL) The highest level of a disinfectant allowed in drinking water.
- Maximum Residual Disinfectant Level Goal (MRDLG) The level of a drinking water disinfectant below which there is no known or expected risk to health.
